MONSTER MUTT LLC RULES & POLICIES (REVISED 3/08)

PICK UP POLICY: Monster Mutt LLC's business hours are posted on the front door. You must pick up your pet by no later than the posted closing time. If you have not picked up your dog by the posted closing time, you will be charged for a night of boarding and you can pick up your dog on the following day. If you do not pick up your pet by 10am the following day, you will be charged for another day of daycare.

BOARDING/SLEEPOVERS: The fees for boarding ("sleepovers") are based on any overnight period up to a 24 hour period. After the 24 hour period normal daycare charges apply (i.e. if you drop your dog off at 10am on Friday and pick up your dog at 7pm on Monday, you will be charged for boarding for Friday, Saturday and Sunday and then for daycare from 10am-7pm on Monday).

RESERVATIONS: We REQUIRE reservations in advance for boarding and daycare. ALL requests for reservations & cancellations must be made via email to reservations@monstermutt.com or monstermutt@monstermutt.com. We will email back to confirm your reservation within 4 hours if you email us during business hours or we will reply by 12n the next day if you email after we are closed. If you do not receive a confirmation in that time frame feel free to call us to follow up. The only exception is if you would like to phone in on the morning you'd like your dog to come in, feel free to call. If we still have openings we will be happy to accommodate you.

CANCELLATIONS: All reservations must be cancelled via email AT LEAST 24 hour in advance of your scheduled arrival. Otherwise you will be charged for the visit. If it is a daycare reservation you will be charged for the day. If it is a boarding reservation, you will be charged for one night of boarding. On holidays and holiday weekends you will be asked for a deposit at the time of the reservation (or when we call to confirm your reservation) and this deposit is NON-REFUNDABLE & NON-TRANSFERABLE, but will be applied toward the total bill for your dog's stay over that designated holiday or holiday weekend.

COLLARS AND LEASHES: All dogs MUST wear a FLAT COLLAR or HARNESS with proper ID tag, rabies tag and NYC dog license while in Monster Mutt LLC's facility. Also, if we are walking your dog outside of our facility or transporting your dog anywhere outside of our facility, we will make every effort to use the leash and collar you provide us with. However, if Monster Mutt LLC determines that your pet will be handled and transported more safely while employing the use of another type of leash or collar, including but not limited to a gentle leader head collar, halti, choke chain, pinch collar, or 6' leather lead, we reserve the right to employ the use of such an item.

PAYMENT: Payment in full is required BEFORE your pet leaves our facility. We accept Visa, MasterCard, American Express and cash. We keep your credit card on file for emergencies only. We require that you allow us to SWIPE your credit card for every transaction, including but not limited to a per visit basis, for retail or if you are purchasing a bulk package. Deposits must be given in person or mailed-in in the form of a personal check. This is the only time we will accept personal checks. If there is no way for us to swipe your card, you will be charge a service fee of \$5/per hundred dollars of your invoice.

DOG TRAINING CLASS REGISTRATION: Upon sign up for dog training classes you must pay a NON-REFUNDABLE & NON-TRANSFERABLE \$100 deposit to guarantee your dog's place in the designated class. The deposit will be applied towards the total cost of the class. Full payment of the balance is due the FIRST day of class. Bring your card to the first class to be swiped. All seminars must be paid for in advance and that payment is NON-REFUNDABLE & NON-TRANSFERABLE to guarantee your dog's place in the designated seminar.

ABANDONMENT POLICY: If your dog is left for more than 72 hours past the scheduled date of pick up, without receiving payment and clear information as to what the new date of pick up will be, the animal will be considered abandoned. In such case, the animal shall become the property of Monster Mutt LLC and we will do as we see fit with the animal, in our sole discretion and at no liability to us, at your sole expense.

UNACCEPTABLE ANIMALS: Monster Mutt LLC reserves in its sole discretion the right to refuse to accept, or to reject upon acceptance, any dog who we believe would not safely integrate with the rest of the animals, or who we believe does not have an appropriate temperament to integrate into our environment. This includes, but is not limited to, aggressive, anti-social, overly active, overly anxious or physically ill dogs.

VACCINATIONS: All dogs are required to be fully vaccinated pursuant to NYC & NYS law (against distemper, parvo, rabies and bordetella) and provide proof thereof. We require a printout from your vet, which you can either bring in to us or have the vet fax directly to us. It is your responsibility to make sure that your pet continues to be fully vaccinated per NYC law while visiting Monster Mutt LLC & you are required to provide us with updated vaccination records for your pet, each time they are vaccinated.

FLEA PROTECTION: All dogs must be wearing flea protection (during all months that the temperature remains above 32 degrees fahrenheit), in the form of a topical liquid, such as Advantage or Frontline. Flea collars are NOT acceptable. If your dog contracts fleas while at Monster Mutt LLC, Monster Mutt LLC is not responsible because proper flea protection is your responsibility.

VETERINARY CARE: Monster Mutt LLC will use our best efforts if your pet becomes ill or injured. We will try to contact you and/or your vet immediately. If that is not possible, and we deem it necessary, we will seek immediate medical attention for your pet, at your sole expense, from the most readily available certified veterinarian. By signing our below, you authorize Monster Mutt LLC and its representatives to act "as owner", at your sole expense, in the case of medical necessity.

MEDICATION: If your dog is boarding with us, please be sure to provide us with a sufficient supply of your dog's medication (and a little extra in case your trip gets extended) and proper instructions on how to administer it. For regular daycare clients we can also keep medication on hand if a mid-day dose is required.

FOOD & FEEDING: We strongly suggest that you provide slightly more than sufficient food for the duration of your dog's stay (in case you get caught out of town). This allows your pup to maintain a consistent diet and avoid any unpleasant stomach upset. If you choose not to provide food, Monster Mutt LLC will gladly provide a top of the line dog food, for a nominal surcharge of \$3/day.

IN SEASON FEMALES/UN-NEUTERED MALES: Monster Mutt LLC does NOT accept any in season females. Should your dog be in season and inadvertently becomes impregnated, Monster Mutt LLC shall not be liable for any resultant litter, illness or medical expenses, or otherwise. All dogs over the age of 8 months must be spayed or neutered.

AUTHORIZATION, ACKNOWLEDGEMENT AND WAIVER

- 1.) I authorize Monster Mutt LLC to maintain my credit card number on file for emergencies and charge services rendered and/or purchases made against the card at the prices then in effect at the time of the transaction, including, without limitation, charges for day care, boarding, bathing, training, grooming and veterinary care as required. I understand that I will still be required to present my card & have it swiped at the time of each transaction. I specifically agree that my dog shall not leave Monster Mutt LLC until all charges are paid to Monster Mutt LLC.
- 2.) If, in my absence, my pet should be injured or ill or is otherwise deemed by Monster Mutt LLC to require immediate veterinary care, Monster Mutt LLC is authorized to consult with my veterinarian for treatment and guidance. If my veterinarian is unavailable, Monster Mutt LLC is authorized to utilize the services of any other reputable veterinarian. I understand that I am responsible for any charges with respect to such veterinary care.
- 3.) I have read and understood the Rules and Policies of Monster Mutt LLC (above), and I ensure the discipline and comportment of my dog in accordance with those Rules and Policies. I understand that Monster Mutt LLC reserves the right to refuse the admittance to and/or use of its facilities of ANY dogs who, in Monster Mutt LLC's sole unfettered determination, are not appropriate animals to participate in the activities available at Monster Mutt LLC, including but not limited to dogs that act aggressively, are undisciplined, evidence inappropriate behavior or who may otherwise be a danger to themselves or other animals or persons.
- 4.) I acknowledge that dogs are encouraged to socialize and exercise at Monster Mutt LLC and understand that injuries, either to dogs, owners or their guests, might reasonably be foreseen to result from the playing that may occur at or around Monster Mutt LLC. I agree for myself, my employees, my invitees (including but not limited to anyone I authorize to pick up or drop off my dog) and my guests to assume the risks and hazards that might reasonably be expected to arise from such use and the presence of animals. I agree that Monster Mutt LLC, its principals and its employees, shall not be responsible for injuries to others (or their pets) who may be injured by my dog or by my acts or omissions or the acts or omissions of my guests, employees and invitees, and I shall indemnify Monster Mutt LLC, its principals and its employees, for any and all costs, damages, claims or expenses (including reasonable attorneys' fees) that may result therefrom. With respect to myself, my employees, my guests and my invitees, I shall hold Monster Mutt LLC, its principals and its employees, harmless from and I shall indemnify Monster Mutt LLC, its principals and its employees, for any and all costs, damages, claims or expenses (including reasonable attorneys' fees) that may result from our use, or the use by our dog, of Monster Mutt LLC's facilities, including, without limitation, incidents associated with the walking or the transporting of our dog outside Monster Mutt LLC's facilities.
- 5.) I attest that my dog is fully vaccinated against Rabies, Distemper, Parvo & Bordetella and I will make sure that I continue to vaccinate my dog in accordance to NYC & NY State laws against these illnesses and provide Monster Mutt LLC with a certificate verifying the updates of these vaccinations. If, for whatever reason, either by neglect or design, I do not vaccinate my dogs against these illnesses, despite the fact most veterinarians recommend that dogs vaccinated regularly, I take full responsibility for any consequence to my animal and/or myself and/or any other animal and/or person. If my dog is a puppy, I understand that most veterinarians recommend that puppies not be exposed to other dogs until they have had at least two, if not all three sets of puppy vaccinations. By allowing my dog to be at Monster Mutt LLC for daycare, boarding, training, grooming or any other reason, without being fully vaccinated, I take full responsibility for any consequence to my animal and/or myself and/or any other animal and/or person. I hold Monster Mutt LLC, its principals, agents and employees, harmless for any illness my pet may contract as a result of exposure to other animals, people or the facility at Monster Mutt LLC.
- 6.) I attest to the fact that my dog is using flea protection and to the best of my knowledge my dog does NOT have fleas. If I am mistaken and an my dog does have fleas or gets fleas due to lack of flea protection or just due to exposure to other dogs, I take full responsibility for any consequence to my animal. I hold Monster Mutt LLC and the owner(s) of the infesting dog, together with their principals, agents and employees, harmless and indemnify for any resulting flea infestation/or complications and/or illness resulting from infestation while my animal is in Monster Mutt LLC's care.
- 7.) I attest to the fact that to the best of my knowledge my dog is NOT in heat. If I am mistaken, and an unwanted pregnancy results, I take full responsibility for any and all consequence to my animal. I hold Monster Mutt LLC and the owner(s) of the impregnating dog, together with their principals, agents and employees, harmless and indemnify them for any resulting pregnancy and/or complications and/or illness resulting from such pregnancy while my animal is in Monster Mutt LLC's care.
- 8.) I waive trial by jury of any and all issues arising in any action, proceeding or otherwise between me, my guests, employees and invitees, and Monster Mutt LLC, its principals and employees, upon, under, or in connection with this Authorization, Acknowledgment and Waiver, and my use and the use by my pet of Monster Mutt LLC's facilities.
- 9.) I understand that Monster Mutt LLC's cancellation policy requires a NON-REFUNDABLE & NON-TRANSFERRABLE deposit for boarding during designated Holidays & Holiday Weekends.
- 10.) I agree to pay Monster Mutt LLC's reasonable attorneys' fees and all costs and other expenses incurred in any collection or attempted collection (whether or not litigation is actually commenced by Monster Mutt LLC) relative to the obligations assumed by me under this Agreement.
- 11.) By signing below, I certify to Monster Mutt LLC the accuracy of all information given about my dog and agree to comply with all of Monster Mutt LLC's Rules & Policies, which I acknowledge having read and fully understood. I certify that I am the owner of this animal and I am authorized to make decisions about my animal's health and safety. I specifically further represent that my dog has not been exposed to rabies, distemper or other disease within a thirty (30) day period prior to being left for boarding, daycare, grooming, training or bathing.
- 12.) This Agreement contains the entire agreement between the parties. All terms and conditions hereof shall be binding upon the successors and assigns of the parties.
